Darin Koelm presented the Engineer's Report.

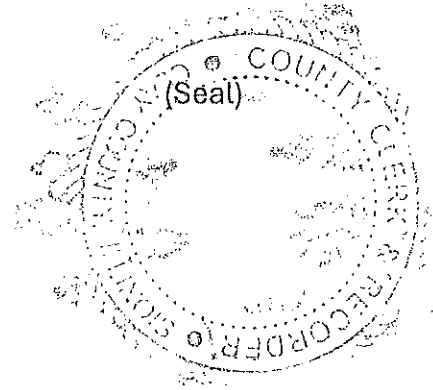
Motion by Kelly Colclasure, seconded by Troy Leonard to approve the final payment for

\$1,950.00. Motion Carried, Roll Call Vote.

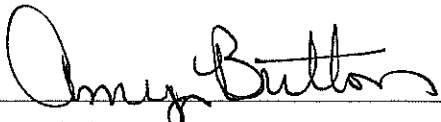
Motion by Mary Cisne, seconded by Cory Hodges to approve the resolution establishing the
